## USE RATE DETERMINATION

Carefully read and follow label directions, including recommended use rates and restrictions. For proper application, determine the size of the area to be treated, the recommended label application rate and the required gallonage for the area to be treated. Prepare only the amount of spray solution needed for the treatment area. Careful calibration of spray equipment is recommended prior to use.

#### MIXING PROCEDURES

Be sure sprayer is clean and not contaminated with other materials prior to use. Fill the spray tank 1/4 to 1/2 full with clean water and start agitation. Be certain the agitation system is working properly and creates a rolling or rippling effect on the liquid surface. With the agitator running, add the required amount of MYCLOBUTANIL 20EW AG to the tank and finish filling tank. Always add MYCLOBUTANIL 20EW AG to the spray tank before adding other materials.

SPRINKLER IRRIGATION: MYCLOBUTANIL 20EW AG must be applied on a regular protectant fungicide schedule, not an irrigation schedule. Apply only through solid set or hand-move sprinkler irrigation systems. Do not apply product through any other type of irrigation system. Crop injury, lack of effectiveness, or illegal residues in the crop can result from nonuniform distribution of treated water. Greatest efficacy is achieved when the application of treated water does not exceed 1/4 inch per acre per application. If you have questions about calibration, you should contact State Extension Service specialists or equipment manufacturers.

There shall be a complete physical break (air gap) between the outlet end of the pipe fill and the top or overflow rim of the reservoir tank of at least twice the inside diameter of the fill pipe.

- The pesticide injection pipeline must also contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.
- The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops, or in cases where there is no water pump, when the water pressure decreases to the point where pesticide distribution is adversely affected.
- The irrigation line or water pump must include a functional pressure switch, which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.
- Systems must use a metering pump, such as a positive displacement injection pump (e.g., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.

## DETERMINATION OF USE RATES ON AN ACRE BASIS FOR TREE CROPS

The amount of MYCLOBUTANIL 20EW AG fungicide required per acre varies with tree size and the volume of fruit and foliage to be treated. The following table provides guidance for the determination of appropriate per acre use rates for MYCLOBUTANIL 20EW AG fungicide:

### CONCENTRATE SPRAY APPLICATIONS

MYCLOBUTANIL 20EW AG fungicide should be used at the recommended use rate per acre in either dilute or concentrate sprays. The following formula should be used to determine the equivalent amount of product per acre in 2X, 3X, etc. spray solutions:

<u>fl oz of MYCLOBUTANIL 20EW AG/acre X 100</u> = fl oz of MYCLOBUTANIL 20EW AG per 100 gallons Spray volume per acre (gallons)

Example: An apple orchard consisting of apple trees 18 feet in height will require 8 fluid ounces MYCLOBUTANIL 20EW AG for adequate apple scab control. Application equipment has been calibrated to apply 80 gallons spray per acre, therefore:

<u>.8 fl oz of MYCLOBUTANIL 20EW AG/acre X 100</u> = 10 fl oz of MYCLOBUTANIL 20EW AG per 100 gallons 80 gallons per acre

#### DILUTE, THOROUGH COVERAGE APPLICATION

Dilute thorough coverage applications are based on the amount of spray solution required to thoroughly wet trees until spray run-off. The following specific use directions for apples utilizes a 400 gallon per acre dilute basis and the specific use directions for stone fruits utilize a 250 gallon per acre dilute basis.

#### USE DIRECTIONS FOR ALMOND

Best disease control is achieved in thorough coverage sprays applied on a protectant schedule that does not exceed 10 days.
