An initial slug addition of $\frac{10\cdot2}{}$ to $\frac{21\cdot6}{}$ fluid ounces of per 1000 gallons of water is recom-RO/CO 2063 mended. Repeat initial dosage until control is evident. Subsequent slug additions of 3.6 to ___ 21.6 fluid ounces of EO/CO 2U63 _ per 1000 gallons of water should be employed. every 1 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the microbiological problem. Slug additions should be made in the sump of water cooling towers.

STORAGE AND DISPOSAL
