STORM STAIN #24 CLEAR WOOD PRESERVATIVE can be recoated after overnight dry with either latex or oil base paint systems.

STORM STAIN #24 CLEAR WOOD PRESERVATIVE protects the wood against moisture and mildew but does not prevent the natural color changes that gradually occur when the surface of the wood is continuously exposed to ultra violet rays from the sun.

PREPARATION

Wood should be clean and dry, well seasoned and free of bark. Mildew must be removed from all surfaces, utilizing a solution of 50% household bleach, 50% water, plus a cup of trisodium phosphate in a 10 quart pail. Areas affected by mildew should be thoroughly scrubbed with this solution, then hosed down with clean water and allowed to dry. Rubber gloves and goggles should be used for personal protection during this process.

APPLICATION

STORM STAIN #24 Clear Wood Preservative should be applied liberally by brush, roller, spray, or by dipping in a container. The more wood preservative absorbed, the more effective the protection. Do not thin — Material is supplied at proper application consistency.

Wood immersion should be for three minutes if dipped.

A single coat is recommended for surfaces to be painted or stained. On porous or rough wood that will remain clear, a second coat is recommended within the hour. EXCESS MATERIAL NOT ABSORBED SHOULD BE WIPED OFF WITH A DAMP RAG WITHIN MINUTES.

Clean equipment, preferably with mineral spirits, immediately after completion of job for fast cleanup.

PRECAUTIONS

Do not apply over painted, varnished or stained surfaces. Do not apply over bank.

Use STORM STAIN #12 Green Wood Preservative for surfaces directly in contact with soil or water

COVERAGE

100-300 square feet — depending on porosity of wood and method of application
