

Apply on above ground untreated wood surfaces such as lumber, fences, trellises, millwork, shingles, siding, door frames, sash, decks and outdoor furniture.

Do not apply over wood that is painted or varnished.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Surface must be clean and free of dirt, oil, grease and mildew. If dirt has caused discolored areas, scrub off with detergent and water. If mildew is present, consult dealer for removing mildew to restore natural tone or wood.

APPLICATION

MIX WELL. DO NOT THIN. Apply liberally by brush, roller or spray by dipping wood. The more STORM STAIN LUMBERCARE the wood absorbs, the deeper and more lasting the protection will be. For extra protection apply a second coat. Do not apply in hot direct sunlight or in temperatures below 40°F. Before applying paint on surface treated with STORM STAIN LUMBERCARE it must be allowed to weather for 6 to 9 months.

COVERAGE

100-300 square feet per gallon depending on porosity of wood and method of application.

CLEAN-UP

Clean equipment with mineral spirits.

NOTE

For wood surfaces where color is desired, use Storm Stain Stain & Wood Preservative which is available in both semi-transparent and solid color types.
