

DIRECTIONS FOR USE: It is a violation of Federal law to use this collar in a manner moonsistent with its labeling. Place Freedom Five collar around the dog's neck, adjust for proper fit and buckle in place. Cut off and dispose of excess length. The collar must be worn loosely so that two fingers can be placed between cellar and dog's neck. If collar is worn too tightly, it may produce neck irritation. Activity against feas states within 24 hours, reaches maximum effectiveness in 3-4 days and continues as long as the collar is worn (up to 150 days). Ticks are relatively harder to kill and die more slowly. Activity against ticks will occur within a few days and will continue killing and controlling bots for up to 150 days, except for unuscually large breads on which collar aids in tick control in the head and neck area up to 2 months. Fleas and ticks present in the animal's environment that may reappear on the dog will be folled and controlled by the action of the collar. Replace collar when effectiveness diminishes. Collar is not affected by normal wetting such as rainfalt, however, it is suggested the collar be removed before bathing.

DISPOSAL: Do not reuse empty pouch or box. After fitting collar wrap pouch or box with excess tollar put in trash collection.
