HAZARD TO HUMANS AND DOMESTIC ANIMALS

CAUTION. This collar is intended for use as an insecticide generator and is not to be taken internally by man or animal. Not intended for use on humans. Do not allow children to handle or play with this collar. May cause contact sensitization following repeated contact with skin in susceptible individuals. Avoid repeated contact with skin. If sensitization reactions result contact a physician. Sensitivities may occur after using ANY pesticide product. If sign of sensitivity occur remove collar and bathe pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately. Do not use on sick or convalescing cats. Do not use on Persian cats. Consult a veterinarian before using this collar on debilitated, aged, pregnant or nursing cats. Do not use other pesticides on cat while collar is worn. Do not use on cats under 20 weeks old.

NOTE TO PHYSICIANS/VETERINARIANS. Diazinon is an organophosphate insecticide, a cholinesterase inhibitor. If symptoms of cholinesterase inhibition are present atropine sulfate by injection is antidotal. 2-PAM is also antidotal and may be administered, but only in conjunction with atropine.

DIRECTIONS FOR USE. It is a violation of Federal law to use this collar in a manner inconsistent with its labeling. Place Freedom Five collar around the cat's neck, adjust for proper fit and buckle in place. Cut off and dispose of excess length. The collar must be worn loosely so that two fingers can be placed between collar and cat's neck. If collar is worn too tightly, it may produce neck irritation. Activity against fleas starts within 24 hours, reaches maximum effectiveness in 3-4 days and continues as long as the collar is worn (up to 150 days). Ticks are relatively harder to kill and die more slowly. Activity against ticks will occur within a few days and will continue killing and controlling ticks for up to 150 days. Fleas and ticks present in the animal's environment that may reappear on the cat will be killed and controlled by the action of the collar. Replace collar when effectiveness diminishes. Collar is not affected by normal wetting such as rainfall; however, it is suggested the collar be removed before bathing.

DISPOSAL. Do not reuse empty pouch or box. After fitting collar wrap pouch or box with excess collar put in trash can. When discarding used collar, wrap inside newspaper and place in trash collection.
