The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, is acceptable subject to the comments listed below:

1) Add the following statement to the Precautionary Statement:

Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum or using tobacco.

- 2) Revise the statement of "Practical Treatment" to read "FIRST AID"
- 3) Revise the IF in EYES and IF on SKIN statements as follows:

IF in EYES: o Hold eye open and rinse slowly and gently with water for 15-20 minutes.

- o Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.
- o Call a poison control center or doctor for treatment advice.

IF on SKIN or CLOTHING: o Take off contaminated clothing.

- o Rinse skin immediately with plenty of water for 15-20 minutes.
- o Call a poison control center or doctor for treatment advice.

- 4) Based on the toxicity profile for this product you are required to list the If on Skin or Clothing and If in Eyes First Aid statements. Therefore, you may delete the If Swallowed and If Inhaled first aid statements.
- 5) Move the statement "Do not use on animals under 12 weeks of age. Consult a veterinarian before using this product on debilitated, aged, medicated, pregnant or nursing animals. Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately. under the Directions for Use section of the label.
- 6) Add a referral statement on the front panel, "See other panels for additional Precautionary statements"
- 7) Revise the Pesticide Disposal Statement as follows:

"If empty: Do not reuse this container. Place in trash or recycling if available If partly filled: Call your local solid waste or [toll free number which meets the criteria in paragraph II.E.] for disposal instructions. Never place unused product down any indoor or outdoor drain."

- 8) Delete the picture of the ferret on the front panel and the phrase, "and Pets" on the side panel. We have no information for use of this type product other than on dogs and cats.
- 9) The product name of record is "**Diatect Pet Powder**". Please submit a request for additional brand name for "Results Pet Powder".
