FOR CRAWLING INSECTS LISTED BELOW: Apply, undiluted, as a contact spray. Adjust pressure and nozzle to deliver a coarse wet spray. When possible, spray directly on roaches, earwigs, grain mites, sowbugs, spiders, and centipedes to reduce infestations. Spray areas to be treated thoroughly.

ANTS: When observed, spray directly. In addition, to control infestations, trails, nests and points of entry may be sprayed.

Repeat if necessary.

FOR FLYING INSECTS: Flies, mosquitoes, and gnats, present on the surface of the refuse, will be killed when sprayed directly with a dilution of 1 part Aquinoc plus 1-½ parts water.

STORAGE & DISPOSAL
