GENERAL PRECAUTIONS AND RESTRICTIONS

Do not storay in face.

This product is not to be used as a terminal sterilant/high level disinfectant on any surface or instrument that (1) introduced directly into the human body, either into or in contact with the bloodstream or normally sterile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body. This product may be used to the body or decontaminate critical or semi-critical devices prior to sterilization or high-level disinfection.

DIRECTIONS FOR USE:

It is a vocation of Federal law to use this product in a manner inconsistent with its labeling.

To Disinatect: Clean surface prior to application. Hold container 6-8 inches from the surface. Spray 3-5 seconds for until surface is wet. Allow to remain wet for 10 minutes and then air dry without wiping. Avoid using somey on delicate fabrics, lacquered, shellacked, or other finished wood surfaces.

To Control Mold & Mildew: Clean surface prior to application. Spray as above. Repeat application in 7 days or as necessary to maintain control.
