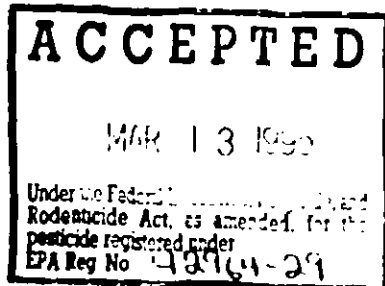

**DIRECTIONS FOR USE:**

It is a violation of federal law to use this product in a manner inconsistent with its labeling. Do not mix with chemicals or other products. **DO NOT DILUTE THIS PRODUCT.** Using trigger sprayer, thoroughly wet surface. Wipe off with dry absorbent cloth or paper towel. To clean, spray on and then wipe away dry and greasy soils, blood, vomit, body oils and soap scum. For disinfection of nonporous hard surfaces, spray and allow to remain wet for 10 minutes. For gross soil, precleaning is required. Product will maintain fungistatic control of mold and mildew for a period of 21 days if not washed or rubbed off. Repeat application when new growth appears. When cleaning food storage or food preparation areas, remove or protect foodstuffs before use. Following cleaning, rinse all food contact surfaces with potable drinking water before use.
