The following amendment, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable with the conditions listed below.

Proposed Amendment

- Update First Aid Statements per PR Notice 2001-1

Conditions

Revise the label as follows:

1. Revise the "If Swallowed" section of the First Aid Statements to read:

IF SWALLOWED: Call a poison control center or doctor *immediately* for treatment advice. Have a person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

2. Delete the word "biodegradable" from the statement "Contains biodegradable detergents and is noncorrosive and nonabrasive." The Agency does not allow claims such as "biodegradable" which imply the safety of a pesticide or its ingredients.



- 3. Revise the statement "...cleaning power with 1,000 ppm of quaternary germicide." to read "...cleaning power with 1,000 ppm quaternary disinfectant." This product must be effective against bacteria, fungi, and viruses to be considered a germicide.

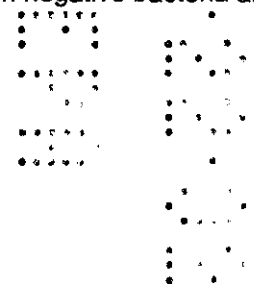

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. DO NOT DILUTE THIS PRODUCT. Using trigger sprayer, thoroughly wet surface. Wipe off with dry absorbent cloth or paper towel. **To clean**, spray on and then wipe away dry and greasy soils, blood, vomit, body oils, and soap scum. **For disinfection** of nonporous hard surfaces, spray and allow to remain wet for 10 minutes. For gross soil, precleaning is required. Effective against *Candida albicans*, *Escherichia coli*, *Pseudomonas aeruginosa*, *Salmonella choleraesuis*, and *Staphylococcus aureus*. Product will maintain mildewstatic control of mold and mildew for a period of 21 day if not washed or rubbed off. Repeat application when new growth appears. When cleaning food storage or food preparation areas, remove or protect foodstuffs before use. Following cleaning, rinse all food contact surfaces with potable drinking water before use.
