Pool Cide Rek-10 is used in swimming pools, exterior spas, whirlpools, hot tubs, and innumerable effectiveness: pools, spas, whirlpools, hot tubs, and heavy growth of algae should be cleaned prior to using.

For pools having just visible algae growth add an initial Pool Cide Rek-10 fluid ounces of Pool Cide Rek-10 per 10,000 gallons of water. Subsequent additions of Pool Cide Rek-10 per 10,000 gallons of water. 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, and decorative fountains require an initial dose of 8 to 12 fluid ounces per 1000 gallons of water. For treatment of a freshly hot tub, or decorative fountain, add initially 4 Pool Cide Rek-10 per 1,000 gallons of 1 to 3 fluid ounces of Pool Cide Rek-10 should be made every 5 to 7 days after initial treatment.


