



**PRECAUTIONARY STATEMENTS  
HAZARDS TO HUMANS

**DANGER:** Corrosive, may cause severe skin irritation or chemical burns to broken skin. Causes eye damage. May be fatal if swallowed. Do not get in eyes, on skin or on clothing. Wear goggles or face shield and rubber gloves when handling this product. Wash after handling. Avoid breathing vapors. Vacate poorly ventilated areas as soon as possible. Do not return until odors have dissipated.

**ENVIRONMENTAL HAZARDS:** This pesticide is toxic to fish. Keep out of lakes, streams or ponds. Treated effluent cannot be discharged into lakes, streams, ponds or public waters unless a discharge permit is obtained. For guidance, contact the regional office of the Environmental Protection Agency.

**PHYSICAL AND CHEMICAL HAZARDS STRONG OXIDIZING AGENT:** Mix only with water according to label directions. Mixing this product with gross filth such as feces, urines, etc., or with ammonia, acids, detergents or other chemicals will release hazardous gases irritating to eyes, lungs and mucous membranes.

**STORAGE &  
DISPOSAL**

Store in a cool, dry area away from direct sunlight. In case of spill, flood area with large quantities of water. Rinse empty container thoroughly with water and either return to manufacturer or discard by placing in trash collection or burying, in an approved landfill. Product or rinsate that cannot be used should be diluted with water and disposed of in a sanitary sewer. Do not contaminate food or feed by storage, disposal or cleaning of equipment.

**GENERAL CLASSIFICATION**  
IT IS A VIOLATION OF FEDERAL LAW TO USE

**NOTE:** This product degrades with age. Use a chlorine test kit and increase dosage as necessary, to obtain the required level of available chlorine.

**START OF SEASON OR FOR NEWLY FILLED SWIMMING POOLS:** Add 10 oz./10,000 gallons of water (equivalent to 1.0 PPM available chlorine). Test with a reliable chlorine test kit and continue adding smaller amounts (1 oz./10,000 gallons equivalent to 0.1 available chlorine). If necessary until a residual of 0.6 to 1.0 PPM is established as determined by the test kit, and maintain at this level. Keep the pH at 7.2 to 7.6 at all times as determined by an adequate pH test kit.

**FIRST AID:** If on skin, wash with plenty of soap and water. If in eyes, flush with water for at least 15 minutes. Get medical attention. If swallowed, drink large quantities of milk or gelatin solution or, if these are not available, drink large quantities of water. Do not give vinegar or other acids. Do not induce vomiting. Get prompt medical attention.
