**Citrus Fruits Postharvest Blue Mold Green Mold and Stem End Rot** Dilute or dilute to 1:1000 and spray at 24 fl. oz./gallon. Apply to flooding or dipping with a spray time of two to three minutes. Follow treatment with adequate fresh water spray.
