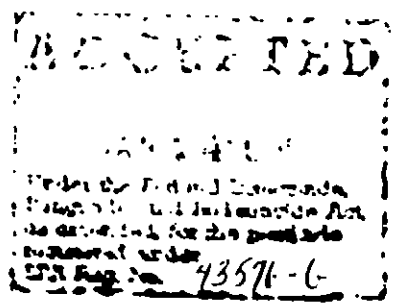

For kennels and living quarters, dust bedding and floor at the rate of 1 ounce per 50 square feet of surface. Repeat as needed.

STORAGE AND DISPOSAL

Do not contaminate feed or foodstuffs by storage or disposal.

PESTICIDE DISPOSAL: Securely wrap original container in several layers of newspaper and discard in trash.

CONTAINER DISPOSAL: Do not reuse container. Rinse thoroughly before discarding in trash.
