The labeling referred to above, submitted in connection with Registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable. A stamped copy is enclosed for your records.

We are accepting the revisions in precautionary text based on reported results for the studies cited above. Although not required, we suggest that you retain the practical treatment statement to flush eyes if contact occurs. You do have a reference to keeping the pesticide out of the animal's eyes.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Use only in a well ventilated area. Remove birds and cover aquariums before spraying.

DOGS, CATS AND RABBITS: Cover animal's eyes with hand and spray head, ears, and chest until damp. With fingertips rub into face around mouth, nose and eyes. Then spray neck, body and legs. For best penetration of spray to the skin, direct spray against the natural lay of the hair. On long haired dogs, cats and rabbits rub hand against the lay of the hair, spraying the ruffled hair directly behind the hand. Make sure spray thoroughly wets ticks. Repeat treatment as needed. To control spinose ear ticks and ear mites, apply 10 drops to each ear so that it can penetrate wax down to surrounding tissues. Repeat treatment once or twice at 2-3 day intervals.

PUPPIES AND KITTENS: Spray only along back or on your fingertips and rub into coat. Do not use on puppies or kittens under 4 weeks of age.

PET SLEEPING QUARTERS: The bedding should be sprayed and then replaced with fresh bedding for best results. Spray floors and carpets, around baseboards, windows, door frames, and wall cracks. If mosquitoes, gnats or flies are present, spray lightly into air.

HORSES AND PONIES: To control stable flies, horse flies, deer flies and face flies apply to face, neck, flanks, topline and other body areas commonly attacked by these flies. Repeat treatment as needed.

STORAGE: Store in a cool dry place (preferably locked) inaccessible to children and pets and away from heat or open flame.
DISPOSAL: Do not reuse empty container. Wrap container in several layers of newspaper and discard in trash.
