

To shampoo and kill fleas and ticks, wet the pet's coat with warm water. Starting at the head, work shampoo thoroughly into the hair. Allow the lather to penetrate the fur for five minutes before rinsing. Dry with a towel. The pet will have a clear lustrous coat, free of fleas and ticks.

Pet bedding and quarters should be treated simultaneously with an approved product.
