### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Shampoo to kill fleas and ticks by wetting the animal's coat with warm water. Starting at the head, thoroughly work shampoo into the hair, avoiding animal's eyes and mouth. Allow the lather to penetrate the fur for 5 minutes. Completely rinse animal's coat to remove shampoo. Towel dry. Do not use on puppies or kittens under 12 weeks. Consult a veterinarian before using this product on debilitated, medicated, aged, pregnant or nursing animals. Do not repeat treatment for 3 to 5 days.

Simultaneously treat pet bedding and quarters with a product labeled for pet quarters flea and tick control.

**Storage:** Store in a cool, dry place (preferably locked) inaccessible to children and pets and away from heat, open flame and sunlight. **Disposal: If empty:** Do not reuse this container. Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency [or 1-800-CLEANUP] for disposal instructions.
