The Agency is in receipt of your Application for Pesticide Notification under Pesticide Registration Notice (PRN) 98-10 for the above referenced product. The Registration Division (RD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10. The label submitted with the application has been stamped “Notification” and will be placed in our records.

The alternate brand name “*R-7M EAR CARE FOR CATS EAR MITE TREATMENT KIT*” has been added to the product record.

Should you wish to add/retain a reference to the company’s website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. Pet Sleeping Quarters: Thoroughly spray, but not to the point of saturation or run-off, infested areas, pet beds, resting quarters, around baseboards, windows, door frames, wall cracks and local areas of floors. Repeat as needed. Put fresh bedding in animal's quarters following treatment. Concurrent treatment of animals is recommended.

Horses and Ponies: To control stable flies, horse flies, deer flies and face flies, apply to face, neck, legs, flanks, topline and other body areas commonly attacked by these flies. Repeat treatment as needed.
