Dear Ms. Davis:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

The alternate brand names R-7 Ear Mite Treatment for Cats, R-7 Ear Mite Treatment for Dogs, R-7 Ear Mite Treatment Kit for Cats, and R-7 Ear Mite Treatment Kit for Dogs have been added to the product record.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. 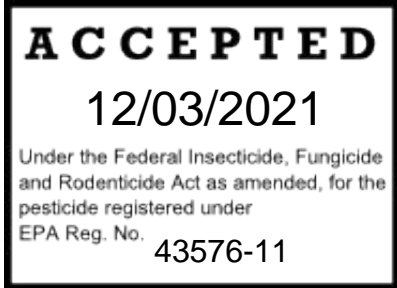

**Pet Sleeping Quarters:** Thoroughly spray, but not to the point of saturation or run-off, infested areas, pet beds, resting quarters, around baseboards, windows, door frames, wall cracks and local areas of floors. Repeat as needed. Put fresh bedding in animal's quarters following treatment. Concurrent treatment of animals is recommended.

**Horses and Ponies:** To control stable flies, horse flies, deer flies and face flies, apply to face, neck, legs, flanks, topline and other body areas commonly attacked by these flies. Repeat treatment as needed.

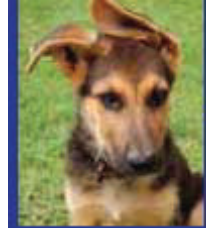
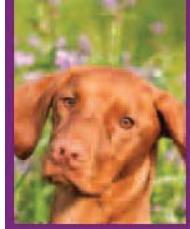
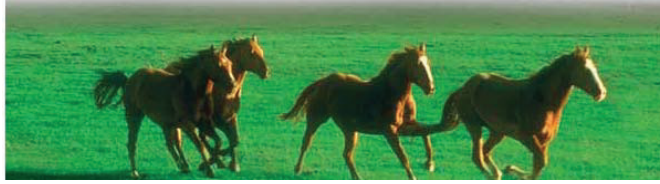
