Dear Ms. Davis:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. “To distribute or sell” is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company’s website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) lists examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product’s label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA’s Office of Enforcement and Compliance.

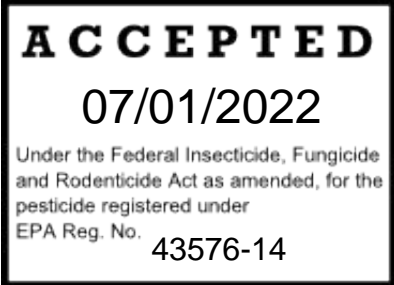

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Do not use on animals under 12 weeks of age. Consult a veterinarian before using this product on debilitated, aged, medicated, pregnant or nursing animals, or animals on medications. Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur, bathe your pet with mild soap and rinse with a large amount of water. If signs continue, consult a veterinarian immediately.

**For Use on Dogs and Cats:**

1. Apply Miracle Care DeFlea Pet Shampoo onto coat of pet. Work shampoo into pet's coat. To improve results, rub into pet's coat and rinse after 5 minutes. Be sure that entire pet is treated, including hard to reach areas such as paws, including between toes.
2. Rinse animal thoroughly, then dry.
3. Repeat as necessary, but not more often than at 3-day intervals.

**Note:** It is vital for young puppies and kittens to maintain a normal body temperature. Take precautions to provide a warm environment during and after bathing.

**For Use as a Spray:**

1. Spray entire animal, including legs and paws, including between toes. Stroke the animal's coat against the lay while spraying to make sure the solution reaches the skin. Spray until entire coat is damp.

2. Do not apply directly to eyes, mouth or nose of the animal.
3. To help solution penetrate to the skin, spray and work into the coat.
4. Dry with towel if desired.
5. In addition to pet, spray on dog and cat bedding that may be infested, making sure adequate product is used to saturate areas where fleas may be hiding. Contacting fleas with product is required to achieve results.
6. Repeat as necessary, but not more often than at 3-day intervals.

**For Use on Reptiles:**

1. Spray directly on reptile, but not to excess (runoff) and all areas where mites may hide. Avoid spraying eyes and facial areas. Alternatively, spray Miracle Care DeFlea Pet Shampoo onto a cloth and wipe onto reptile.
2. Reapply as often as necessary but not more often than at 3-day intervals.
3. Do not treat snakes for at least 6 hours after they shed their skin.

Miracle Care DeFlea Pet Shampoo may also be used to clean surfaces of terrariums and other habitats. Spray surfaces with Miracle Care DeFlea Pet Shampoo and wipe with a clean cloth. Rinse and dry surfaces before reintroducing reptile to habitat. **Not for Use on Amphibians such as Frogs and/or Toads.**

**Storage and Disposal**

Do not contaminate water, food or feed by storage or disposal.

**Pesticide Storage:** Store in a cool, dry place inaccessible to children and pets. **Pesticide Disposal/Container Handling:** Non-refillable container. 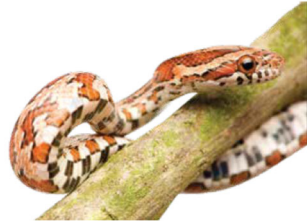

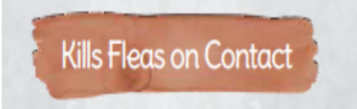
