

GENERAL DIRECTIONS

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. RIDE-1 is a ready-to-use insecticide dust which can be applied through the use of self-treating dust bags, or by hand. But do not apply with bare hands. Use dust mitt or other protective glove.

DIRECTIONS FOR USE ON HORSES

For aid in the control of face flies, for the control of stable flies, house flies, horn flies, horse flies, deer flies, lice, ticks, gnats and fly larvae.

HAND DUSTING — Apply approximately 2 oz. of RIDE-1 by shaker can, hand duster, grooming brush, or dust mitt. Cover upper portions of back and neck. For added control of face flies, apply to the face, mane and tail. Rub or brush lightly to carry dust beneath.

Repeat as necessary.

PREMISE DUSTING — Apply to barn or stall area floors where manure accumulates, to control fly larvae and flies in the stable area.

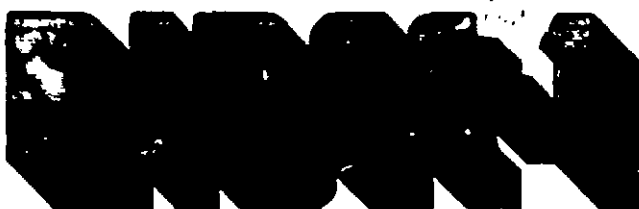
