Your Application Dated March 18, 1988

The amendment referred to above, submitted in connection with registration under section 3(c)(7)(A) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is acceptable provided that you:

1. Submit/cite all data required for registration/reregistration of your product under FIFRA section 3(c)(5) when the Agency requires all registrants of similar products to submit such data.
2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
 - a. Change Active Ingredients to the singular.
 - b. Indicate a total on the ingredient statement. The sum of the declared percentages must equal 100%.
 - c. Place an asterisk next to Inert Ingredients and the xylene and Rhodamine B statements.
3. Submit five (5) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

**PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS
AND DOMESTIC ANIMALS
WARNING**

May be fatal if swallowed. May be absorbed through skin. Do not breathe spray mist. Do not get in eyes, on skin, or on clothing. Causes eye and skin irritation. Wash hands, arms and face thoroughly with soap and water after handling and before eating or smoking. Routinely shower or bathe after working and wash work clothes with soap and hot water before reusing. Do not contaminate food and feedstuffs.

For seed treatment, applicators who apply this product manually or without the use of a closed-system treatment procedure must wear long-sleeved shirt, long pants, gloves, and a disposable paper dust mask which covers at least one-third of the face. The product must be applied in a well-ventilated area.

ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish, birds and other wildlife. Do not apply directly to water or wetlands. Do not contaminate water by cleaning of equipment or disposal of wastes. Do not contaminate water when disposing of equipment washwaters.

Treated seed may be hazardous to birds and other wildlife. Dispose of excess treated seed by burial away from bodies of water.

PHYSICAL OR CHEMICAL HAZARDS

Do not use, pour, spill or store near heat or open flame

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited.

STORAGE: Store in a cool, dry place. Do not allow to freeze or become overheated. Store away from food or feed, in an area designated for pesticides. Store in original container only. Keep container tightly closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes are toxic. Improper disposal of excess pesticides, spray mixture, or rinsate is a violation of Federal Law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance.

CONTAINER DISPOSAL (Metal) Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.

CONTAINER DISPOSAL (Plastic) Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.

SEED TREATMENT: Do not use treated seed for food, feed, or oil purposes. Treated seed should be labelled in accord with all the applicable requirements of the Federal Seed Act. The Federal Seed Act requires that seed treated with a pesticide must contain a dye which imparts an unnatural color to the seed if the seed is intended to be moved in interstate commerce. Labels attached to treated seed must state, "Treated seed must not be used for food, feed or oil purposes," and "Excess treated seed may be hazardous to birds and other wildlife. Dispose of excess treated seed by burial away from bodies of water."

Only seed of high germination with good vigor should be treated with lindane. Poor seed may suffer greater injury. Treat seed not over 6 weeks before planting. Store treated seed in a dry place until planted so that excess moisture will evaporate. If seed is stacked when wet, heat may develop which could impair germination.

Statement of Precaution
