DIRECTIONS AND APPLICATION RATES

This product is an agricultural fungicide formulated for seed treatment purposes. It contains effective binding agents which reduce "dusting-off" of the treatment. It should be thoroughly mixed with water and applied as a suspension in the slurry-type treater designed and approved for this purpose, or may be applied by hand in any suitable mixing equipment such as home-made rotary drums. Use this product in combination with a standard fungicide.

FOR SLURRY-TYPE TREATER: Use by mixing with water in a slurry treater at the concentration necessary for the type of slurry equipment being used and the seed being treated. Maintain constant agitation during treatment to avoid settling.

FOR HAND SLURRY TREATMENT: Consult the following information for the number of ounces of this product recommended for each 100 pounds of seed. Measure out this amount and add to a sufficient quantity of water to give thorough and even coverage of the seed to be treated (approximate dilution rates are 1 part of this product mixed with 4 or 5 parts of water). Agitate well until product is evenly dispersed in water. Place seed in a mixing container or spread in a 4-inch layer on floor on a clean dry paper. Sprinkle the measured amount of slurry suspension over the specified amount of seed and mix immediately. Turn seed at least 5 times and allow to dry before planting.

IMPORTANT: Treated seed must not be used or mixed with food or animal feed, or processed for oil. Treat only those seeds needed for immediate use, minimizing the interval between treatment and planting. Do not store excess treated seeds beyond planting time. Seed commercially treated with this product must be labeled in accord with all applicable requirements of the Federal Seed Act. Labels attached to treated seed must state "Treated seed must not be used for or mixed with food or animal feed, or processed for oil," and "Exposed treated seed may be hazardous to birds and other wildlife."

BEANS: For control of *Rhizoctonia solani*, *Pythium* Spp., and Seed and seedling diseases, use 1.6 - 4.6 fluid ounces of this product per 100 pounds of seed.

SOYBEANS: For control of *Rhizoctonia solani*, *Pythium* Spp., and Seed and seedling diseases, use 1.6 - 4.6 fluid ounces of this product per 100 pounds of seed.

COTTON: For control of *Rhizoctonia solani*, *Pythium* Spp., *Sclerotium rolfsii*, and Seed and seedling diseases, use 5.3 - 11.2 fluid ounces of this product per 100 pounds of seed.

SUGAR BEETS: For control of *Rhizoctonia solani*, *Pythium* Spp., and Seed and seedling diseases, use 2.4 - 6.8 fluid ounces of this product per 100 pounds of seed.

Use high rate on pathologically infested seed or for soils such as in California.
