

**PRECAUTIONARY STATEMENTS

POTATO SEED TREATER is an Agricultural Fungicide in a dust form. It is useful for treating Potato Seed Pieces and Whole Potato Seed for the control of Fusarium Seed Piece Decay, Verticillium Wilt and Damp-off. Apply 1½ pounds of this product to each 100 pounds of cut seed pieces. For best control this product must be applied evenly to the entire surface of each piece immediately after cutting. If the treated whole seed is later cut, a second application will be necessary. If planting is delayed, follow recommended storage practices of cut seed pieces in your area. Do not use treated seed pieces for food or feed purposes.
