DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

NET CONTENTS: _____

To prepare dilutions the concentrate should first be stirred or agitated well. Add required amount of concentrate to water and blend thoroughly. This will produce a micro-emulsion.

For maximum effectiveness, a combination of localized surface application and space treatment is recommended.

AS A SURFACE SPRAY: For initial clean severe insect infestation, dilute at a 1 part concentrate in 14 parts water (8 ounces per gallon). This dilution may be used in edible product areas of Federal inspected meat and poultry plants. In plants and for normal infestations dilute 1 part concentrate in 29 parts water (4.3 ounces per gallon).

To control cockroaches, ants, silverfish crickets, clover mites, cheese mites, giant weevils, rice weevils, confused flour beetle, rust red flour beetles, sawtoothed grain beetle, spider beetles, cigarette beetles, drug store beetles, meal worms, grain mites and carpet beetles.

Use a good sprayer adjusted to deliver a fine wet spray. Direct the spray into hiding places, cracks and crevices, under pallets, around containers of stored foods, around the base of machinery, behind shelves and drawers, under bookcases for silverfish. Spray ant nests and points of entry. If surface application only is to be used, spray floors and other surfaces applying at a rate of 1/2 to 1 gallon per 750 square feet of surface.

To control carpet beetles, spray edges of baseboards and under carpeting and rugs. Make application to floor and baseboards. Spray directly into cracks, closets and infested areas of shelving. Repeat treatment as needed.

To control bedbugs: Spray mattresses and box springs particularly around tufts and seams. Separate and spray in all joints. Treat bed frames, moldings and floors. Repeat treatment as needed.

BATCH

To control fleas, and brown dog ticks: Thoroughly spray infested areas, pet beds, resting quarters, nearby cracks and crevices, along and behind baseboards, moldings, window and door frames and localized areas of floor and floor covering. Fresh bedding should be placed in animal quarters following treatment. To kill fleas and ticks on cats and dogs, and to obtain protection against reinfestation, dilute at 1 part concentrate to 19 parts water (6.4 fluid ounces per 1 gallon) and wet the animal by dipping or spraying.

AS A SPACE SPRAY: Dilute at a rate of 1 part concentrate to 19 parts water (6.4 fluid oz. per gallon). Apply with mechanical or compressed air equipment (non-thermal) adjusted to deliver a fine mist. Close doors and windows and shut off ventilating systems. For rapid control of adult house flies, fruit flies, gnats, mosquitoes, skipper flies, wasps, hornets, Angoumois grain moths, Mediterranean flour moths, Indian meal moths, and tobacco moths: Direct spray at an upward angle distributing it uniformly through the entire area at a rate of 1 ounce per 1000 cubic feet of space. Keep area closed for at least 10 minutes. Ventilate and sweep up dead insects before reoccupying.

For rapid kill of exposed or accessible stages of other insects named on this label; dilute 1 part concentrate in 1 - 9 parts water (13 to 64 ounces per gallon). Apply using conventional, mechanical or compressed air equipment (non-thermal), following directions for space spraying. Apply the above dilutions at a rate of from 1 to 10 ounces per 1000 cubic feet of space. When used in meat and poultry processing plants, a dilution of no less than 1 to 1 is acceptable and it must be dispersed from equipment adjusted to deliver an aerosol spray (no droplets over 50 microns in diameter and 80% less than 30 microns).

IN MUSHROOM PRODUCTION AND PROCESSING: To control adult Mushroom flies, or Fungus gnats, Phorids, Sclerids, and Lecidomyiids in growing houses. Dilute 1 part concentrate in 1 part water (6.4 fluid ounces per gallon). Using mechanical or compressed air equipment (non-thermal) adjusted to deliver a fine mist, apply at a rate of 1 ounce per 1000 cubic feet of space. Fogger should be operated 5 to 10 feet away from beds and directed slightly upward over them. Circulating fans should be left in operation, but for best results refrigeration should be turned off. In packing and canning plants use at a rate of 1 ounce to 1000 cubic feet of space.

OUTDOORS: To kill gypsy moth caterpillars and adults, adult Japanese beetles and Eastern arid forest tent caterpillars on contact: combine 3.0 fluid ounce of concentrate per 1 gallon of water. Apply to insure thorough coverage of upper and lower surfaces.

On Trees and Shrubs: Treat trees and shrubs as soon as insects emerge (usually late spring). Treat leaves, branches and tree trunks evenly, making sure to penetrate dense foliage. Repeat application every 7 days as necessary for control.

On Roses and In Flower Gardens: Treat plants and flowers as soon as insects appear. Spray plants and flowers making sure to penetrate dense foliage. Repeat application every 7 days or as necessary for control.

DISPOSAL

Do not reuse empty container. Wrap container and put in trash collection.

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION

Harmful if swallowed. Remove pets, birds and cover fish aquaria before spraying. Do not breathe spray mist. Wear mask or respirator of a type recommended by the U.S. Bureau of Mines to give adequate protection against this material. Wear protective clothing. Wash exposed skin surfaces with soap and water after handling and before eating or smoking. Wash all contaminated clothing with soap and water before reuse.

Do not apply as a space spray while food processing is underway. Except in Federally inspected meat and poultry plants, when applied as a surface spray with care and in accordance with the directions and precautions given above, food processing operations may continue. Do not apply at any time as a undiluted space spray in edible product areas of Federally inspected meat and poultry plants. Foods should be removed or covered before treatments. Thoroughly wash all food processing surfaces before reuse. All surfaces in processing areas must be washed and rinsed in potable water after spraying.

ENVIRONMENTAL HAZARDS

This product is toxic to fish. Do not apply directly to lakes, streams, ponds, tidal marshes, and estuaries. Do not contaminate water by cleaning of equipment or disposal of wastes.
