DANGER

WHEAT & BARLEY: For control of common root rot (*Helmintosporium sativum*) and barley leaf stripe, use 0.2-1.5 fl. oz. FECUNDAL 10EC per 100 lbs of seed.

COTTON: For control of Fusarium and Thielaviopsis use 4-8 fl. oz. Pecundal 10EC per 100 lbs. of seed.

Use the higher dose when disease pressure is severe.

For ready mix treaters, Pecundal 10EC may be applied directly to the seed. For slurry treaters, Pecundal 10EC may be diluted with water.

SEED LABELLING: Seeds treated with Pecundal 10EC. Do not use treated seed for food, feed or oil purposes. Do not graze or feed foliage from treated area to livestock.

USE PRECAUTION: All seed treated with this product must be adequately dyed. Any dye added to treated seed must be cleared for use under 40 CFR, Part 180.1001.

NOTE TO USER: Combination treatments of FECUNDAL 10 EC with products containing lindane may result in delayed emergence and stunting of wheat and barley, however, plants will usually outgrow this effect. Do not carry over seed treated with lindane to the next crop season. Minimize time between treating and planting for such treatments.

Treatment of highly mechanically damaged seed, of known low vigor and poor quality, except for the purposes of curative control of existing disease or insect pests, can result in reduced germination and/or reduction of seed and seedling vigor.
