
NOTE: This product is **not** being reregistered under sections 3(c)5 and 4(g) of FIFRA at this time.

- Metal Working fluids
- Dry film preservative of coatings and building materials
- Non-food contact paper and paperboard products, wallboard (drywall and gypsum board), ceiling tiles, rubber and plastic products, leather (wet leather stock such as pickled, vegetable-, chrome-, alternative metal or metal free tanned hides and skins) and textiles (shower curtains, carpet backing, awnings, boat covers, canvas, cordage, tents, tarpaulins, and wall coverings).

Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill, or by other procedures approved by state or local authorities.
