The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Imazalil and Imazalil Sulfate Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance Assurance.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling and must be used at your next label printing. You must

submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 12 months from the date of this letter. After 12 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

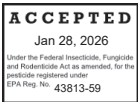
Users should wash hands before eating, drinking, chewing gum, using tobacco, or using the toilet.

ENVIRONMENTAL HAZARDS

This chemical is toxic to fish. Do not apply directly to water, to areas where surface water is present, or to intertidal areas below the mean high-water mark. Runoff from treated areas may be hazardous to aquatic organisms in neighboring areas. Do not contaminate water when cleaning equipment or disposing of equipment washwaters or rinsate.

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling. Do not apply this product in a way that will contact workers or other persons. Only protected handlers may be in the area during application.



STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

Pesticide Storage: Store in a cool dry place in the original container away from food and feed.

Container Handling: Nonrefillable container. Do not reuse or refill this container.

Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows:

[For plastic containers that are small enough to shake] - Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds.

Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

[For fiber drums or paperboard containers with plastic liners] - Completely empty liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment.

Then offer for recycling if available or dispose of in a sanitary landfill, or by incineration. If drum is contaminated and cannot be reused, dispose of it in a manner required for its liner.

FUNGAFLOR 750 WSP is an imidazole fungicide in the Group 3 class of fungicides that inhibits sterol biosynthesis which results in disruption of membrane structure and function, thus affecting cell wall permeability. Because resistance development cannot be predicted, postharvest resistance management strategies and sanitation practices should be followed. Fungal isolates with acquired resistance to Group 3 fungicides, may eventually dominate the fungal population if Group 3 fungicides are used repeatedly or in successive years as the primary method of disease control for the

targeted pathogens. This may result in partial or total loss of control of those fungal species with imazali or other Group 3 fungicides. A disease management program that includes alternation or tank mixes between FUNGAFLOR 750 WSP and other labeled fungicides that have a different mode of action, may prevent pathogen populations from developing resistance.

To delay fungicide resistance, take one or more of the following steps:

- Rotate the use of imazali or other Group 3 fungicides, during a growing season sequence, such as long-term storage and prior to extended transport conditions, with different fungicide groups that control the same pathogens and in which the pathogen population is still highly sensitive to that fungicide or fungicide Group.
- Use tank mixtures or alternate with combination products containing fungicides from different fungicide groups that are equally effective when such use is permitted. Use at least the minimum application rate as labeled by the manufacturer.
- Adopt an integrated disease management program for fungicide use that includes monitoring fungal populations in the packinghouse and fruit storage rooms for resistance development using different available sensitivity monitoring techniques, historical information related to pesticide use, impact of packinghouse storage conditions on disease development and thresholds, as well as cultural, biological and other chemical control practices.
- Where possible and practical, make use of predictive disease models to effectively time fungicide applications. Note that using predictive models alone is not sufficient to manage resistance.
- Contact your local service company, Janssen PMP, or your local extension specialist for information on packinghouse spore monitoring programs and for any additional resistance management and/or Integrated Pest Management (IPM) recommendations for specific crops and pathogens.

Intended for post-harvest control of *Penicillium digitatum* (green mold), *Penicillium italicum* (blue mold), *Diaporthe citri* (phomopsis stem end rot), *Diplodia natalensis* (diplodia rot) and *Alternaria citri* on citrus fruits.

FUNGAFLOR 750 WSP® is formulated for aqueous application only; not compatible with storage or shipping wastes. Used as directed, FUNGAFLOR 750 WSP has curative and preventative action as well as anti-sporulation properties. Use of FUNGAFLOR

750 WSP should be integrated into an overall disease management program within each packinghouse.

DOSE REQUIREMENTS:

In dips, wash tanks, and drenchers: Weigh out 9 - 13.5 ounces (0.42 - 0.63 lbs. active ingredient imazali) of FUNGAFLOR 750 WSP and dissolve in 100 gallons of water to give a treating rate of 500-750 ppm of active ingredient. The treatment solutions must be monitored to insure the proper concentration of FUNGAFLOR 750 WSP. Length of dip time must not exceed two minutes.

In non-recovery spray & water spray brush application: Dissolve 18 ounces (0.84 lbs. active ingredient imazali) of FUNGAFLOR 750 WSP in 100 gallons of water to achieve a concentration of 1000 ppm FUNGAFLOR 750 WSP active ingredient. Apply to freshly cleaned citrus prior to waxing.

Remarks

- Combinations of above-listed treatments are possible, but never more than two (2) treatments may be carried out on the same citrus lot.
- Application restrictions for citrus drench: Stay outside of treatment area until citrus is treated and drained. The windows and doors of the transport vehicle must be closed prior to treatment.
