

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

1. Fill plastic measuring cup to circular mark with methyl alcohol. DO NOT USE GASOLINE OR CHARCOAL LIGHTER FLUID.
2. Remove top of unit's cover. Without touching the wire mesh, remove metal burner cover from base. Set aside.
3. Carefully pour pre-measured methyl alcohol on the absorbent material in the unit's base. Do not overfill. Immediately wipe dry any spillage.
4. Without touching the wire mesh replace metal burner cover on base. Holding base of unit in vertical position, heat wire mesh with lighter or match for 10-15 seconds until interior of gauze glows. Blow out any flame that may appear. If for any reason the burner goes out, repeat this procedure. Do not light in tents or other enclosures.
5. Remove Spira mat from foil and slide under the protective grill. Replace top cover on metal base and place unit up-wind. Do not touch either the wire mesh or the metal base while unit is in use – wait until the unit has cooled. Mat's color turns pink when repellent in mat has been exhausted and mat needs replacing.
6. To extinguish burning unit, carefully remove top cover. Cover with measuring cup for 1 to 2 minutes.
7. To replace mat, extinguish burner and allow base to completely cool. Insert another mat under protective grill. The used mat will automatically fall out when you push in the new mat. To activate mat, just relight the burner and replace base's top cover.

For best results place Spira Open Air Mosquito Repellent in confined areas such as porches, patios, yards and similar areas where there is a minimal breeze. Try Spira Open Air Mosquito Repellent around the house, on the patio, on picnics/barbecues, camping, boating, fishing and outdoors wherever mosquitoes are an annoyance. Keep burner clean and protect from moisture. Do not leave lit unit unattended. Use only Spira Mats in unit.

Storage: Store unit and unopened mats in a cool, dry (preferably locked) storage area inaccessible to children and pets. **Disposal:** Do not reuse spent mats; wrap and put in trash.
