**DIRECTIONS FOR USE**

*It is a violation of Federal law to use this product in a manner inconsistent with its labeling.*

For best results place one coil about every 8-10 feet (2-3m) around perimeter of area to be protected. Most effective in semi-confined outdoor sites such as porches, patios, open gazebos, pavilions, shelter-halves, lean-tos in lee of wind direction. Duration and results are affected by airflow and breeze. Save the stand after use to permit burning more coils with future packages.
