# USE DIRECTIONS

The use of this product in food processing plants should be confined to time periods when the plant is not in operation. Foods should be removed or covered before treatment. Remove pets, birds, and cover fish aquariums before spraying. Thoroughly wash dishes and food handling utensils if contaminated by this spray.

To control Flies, Mosquitoes, Gnats and Flying Moths (Millers): Apply using a good space sprayer adjusted to deliver a fine mist. Close windows and doors and shut off ventilating systems. Direct spray toward upper portions of the enclosure, filling the atmosphere with mist. Use 2 to 3 ounces per 1000 cubic feet of space. For best results, keep area closed for at least 10 minutes. Vacate treated area and ventilate before reoccupying. Repeat treatment as necessary.

To control <u>Silverfish</u>, <u>Crickets</u> and <u>House Spiders</u>, spray thoroughly into hiding places particularly in cracks, crevices, moist areas, around openings for plumbing or wiring, under sinks, cabinets, stoves, refrigerators, and pallets. Spray insects directly whenever possible. Repeat tretament as necessary.

To control Ants, spray trails, nests and points of entry. Spray directly on ants whenever possible. Repeat treatment as necessary.
