Prior to its use, must be cleaned to remove algal growth, microbiological slime, and deposits. An initial slug addition of 1.5 to 3.0 fluid ounces of IWE 1,000 gallons of water is recommended. Repeat initial dosage until is evident.

Subsequent additions of 0.5 to 3.0 fluid ounces of IWE 6135 p gallons of water should be employed every 1 to 5 days, or as need frequency of addition depends upon the relative amount of bleedoff severity of the microbiological problem. Slug additions should be the sump of water cooling towers.
