Controls: Sod Webworms, Armyworms, Chinchbugs and Cutworms.

Apply Leisure Lawn 30-10-0 with Dursban uniformly to home lawns and other ornamental and recreational turf grass areas using any hand or power-operated rotary-type spreader designed for application of granular materials. Treat when insects first appear using Leisure Lawn 30-10-0 with Dursban at the rate of: 2.5 lbs. per 1,000 square feet, or the equivalent of 1.0 lbs. chlorpyrifos per acre. To help obtain uniform distribution, apply one-half the required amount of product in one direction; then apply the balance at a right angle. Immediately after application sprinkle the turf with 1,000 gallons of water per acre so as to wash the granules into the zone of insect infestation.

APPLICATION EQUIPMENT: Apply Leisure Lawn 30-10-0 with Dursban evenly over the turf area without skips or misses. Follow application rates carefully; do not overlap or over-apply. Over-application can weaken turfgrass during stress periods allowing fungus or insects to cause damage. Rotary-type spreaders should be used to apply Leisure Lawn 30-10-0 with Dursban. Calibrate applicators prior to use according to the manufacturer's directions. Check frequently to be sure equipment is working properly and distributing granules uniformly.
