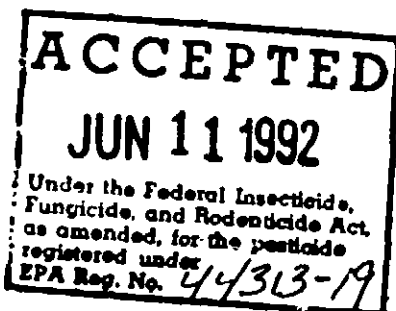

PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals

Statement of Practical Treatment

Swallowed: Immediately contact a physician or poison control center. Give person 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store in original container away from food and feed stuffs. Keep product in a locked storage area.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: Completely empty container into application equipment. Triple rinse thoroughly, depositing rinse into application equipment. Dispose of empty container in a sanitary landfill.

To use in steam injection/extraction cleaners along with detergent:

1. FOR USE IN HOT WATER EXTRACTION (STEAM) CARPET CLEANING EQUIPMENT:

- Mix 8 ounces (net weight) of powder with each gallon of cleaning solution.
- A gallon will treat approximately 165-200 square feet.
- Clean carpet as directed by equipment manufacturer.

2. FOR USE AS A "LAST PASS" APPLICATION AFTER CLEANING CARPET:

- As a final pass after cleaning or as a touch-up, mix 12 ounces (net weight) of powder per gallon of warm/hot water. A gallon will treat approximately 165-200 square feet.

3. AS AN ALTERNATIVE USE THE FOLLOWING METHOD AND FORMULA:

- Vacuum/clean carpet in normal fashion.
- Mix 12 ounces (net weight) of powder to one gallon of warm/hot water.
- Spray mixture over carpet at the rate of 165-200 square feet per gallon.
- Rake, brush or roll the spray into the carpet.

4. FOR USE AS A SPRAY FOR FURNITURE, DRAPES, BASEBOARDS, PET BEDDING, CONCRETE AND DIRT FLOORS:

- Mix 12 ounces (net weight) of powder with one gallon of warm/hot water.
- Before treating furniture or drapes, test small area to evaluate staining.
- When treating couches and chairs, remove cushions, vacuum and spray all crevices. **DO NOT SATURATE.**
- Lightly spray bottom two feet of drapes. **DO NOT SATURATE.**
- Spray all pet sleeping areas, including pet bedding. **DO NOT SATURATE.**
- Treat all baseboards, concrete and dirt floors with a light spray.

5. FOR USE AS A DRY POWDER APPLICATION ON DRY CARPET SURFACES, FURNITURE, FLOORING OR BASEBOARDS:

- Vacuum carpet, furniture (couches and chairs), floor and baseboards. Remove carpet cleaner bag and seal in garbage bag prior to disposal.
- Sprinkle powder at a rate of 8 ounces (net weight) per 165-200 square feet.
- Brush powder into the carpet and into all crevices. Do not vacuum for 48 hours.
