ROACH & ANT SPRAY
PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS AND DOMESTIC ANIMALS
CAUTION

Harmful if swallowed. Avoid breathing of spray mist or contact with skin. Wash with soap and water after using and before eating or smoking. Avoid contamination of food and foodstuffs. Do not use on household pets or humans. Remove pets and cover fish bowls before spraying. Do not allow children or pets on treated areas until surfaces are dry. For spot application only. Do not use as a space spray.

PHYSICAL AND CHEMICAL HAZARDS

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 130° may cause bursting.

ENVIRONMENTAL HAZARDS

This product is toxic to fish, birds and other wildlife. Keep out of lakes, streams or ponds. Do not contaminate water by disposal of wastes. Apply the product only as specified on this label.

STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED - Call a physician immediately. Gastric lavage is indicated if material was taken internally. DO NOT INDUCE VOMITING unless other treatment is not available. Vomiting may cause aspiration pneumonia. If it is necessary to induce vomiting, give victim one or two glasses of water and insert finger in back of throat. Repeat until vomiting fluid is clear. Do not induce vomiting or give anything by mouth to unconscious person.
IF INHALED - Remove victim to fresh air. Apply respiration if indicated.
IF ON SKIN - Wash contaminated skin with soap and water.
IF IN EYES - Flush eyes with plenty of water for at least 15 minutes. Get medical attention immediately.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Do not use in edible product areas or food processing plants, restaurants, or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.
Remove cap, hold can upright, point valve opening away from person. Hold can about 12 inches from surface being sprayed. Press button to release spray. Spray surfaces until wet. Do not spray heavily on asphalt tile or linoleum, as ingredients may be harmful to some such surfaces.
ROACHES, SILVERFISH, WATER BUGS, SPIDERS AND CRICKETS: Direct spray into cracks, on baseboards, window and door trim, under cabinets, stoves, sinks, and around pipes. Spray surface until wet. Spray directly on crawling insects whenever possible. Repeat as necessary.
ANTS: Use above directions and also observe runways; spray these thoroughly. Locate ant hills outdoors and spray opening thoroughly. Repeat as necessary.
CARPET BEETLES: Make localized application to areas of the floor and baseboards. Spray directly into cracks and under carpets where insects may be found. Treat crevices, cracks and closets and infested areas of shelving. Repeat as necessary.
MOSQUITOES, FLIES, WASPS AND OTHER FLYING INSECTS: For outdoor use only as an aid in reducing annoyance from these insects. Spray on surfaces of screens, door and window frames, porches, light fixtures, garages and other places where these insects alight, congregate, or wherever insects may enter room.
DISPOSAL: Do not reuse empty container. Wrap container and place in trash collection.
