Dear Mr. Whitney:

The proposed amendment to the registration for the product cited above under The Federal Insecticide, Fungicide And Rodenticide Act, as amended revising the label in response to PR Notices 2001-1 and 2001-6 is acceptable subject to the comments listed below. This letter is also a response to your application dated June 30, 2000 in response to the Deet RED. For purposes of this letter, our comments and requested changes are in response to the label submitted on June 7, 2003.

1) Change the Precautionary Statements to read as follows:

"Harmful if swallowed. Causes moderate eye irritation. Avoid contact with eyes. Use of this product may cause skin reactions in rare cases. Wash treated clothing before wearing it again. Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet."

2) The First Aid statements for If Inhaled and If on skin or clothing are not needed and can be deleted.

3) Change the statement, "If you suspect that you or your child is xxx poison control center." to read as follows and place it in the First Aid section of the label:

"If you suspect a reaction to this product:

- * Discontinue use;
- * Take off contaminated clothing;
- * Rinse skin immediately with plenty of water for 15-20 minutes;
- * Call a poison control center or doctor for treatment advice.

4) Add the statement, "For additional information in case of emergency call toll free (insert Telephone Number)."

5) The percentage of DEET in the Ingredient Statement must be changed to 14.25%.

6) Change the statement, "Read all directions before using this product." to read "READ AND FOLLOW ALL DIRECTIONS AND PRECAUTIONS ON THIS PRODUCT LABEL." and place it after the general misuse statement.

7) Change the disposal statement to read:

PESTICIDE STORAGE: Do not store near heat or open flame.
CONTAINER DISPOSAL: "Do not puncture or incinerate!
IF EMPTY: Place in trash or offer for recycling if available.
IF PARTLY FILLED: Call your local solid waste agency (or toll free number which meets the criteria in paragraph II.E of PR Notice 2001-6) for disposal instructions.

8) Add the following statements to the label:

- "Apply sparingly around ears."
- "Do not allow children to handle this product."
- "When using on children, apply to your own hands, and then put it on the child."
- "Avoid over-application of this product."
- "If used on face, spray on hands first and then apply sparingly and avoid eyes. Do not spray directly onto face."

This product is not being re-registered at this time. Product specific efficacy data will be required. Once the efficacy guidelines are in place, you will be notified of the efficacy requirements.


Also, to meet the requirement of the DEET RED, the product must be packaged in containers utilizing a concave trigger to help aim the product or other comparable mechanism that will ensure that the product will not be inadvertently sprayed in the eyes.

A stamped copy of the amended label is enclosed for your records. Submit two copies of the final label before the product is released for shipment under this revised label.

The Confidential Statement Of Formula dated May 2, 2001 is acceptable and has been placed into the file for this product.
