**Subject: Amended Reregistration Label for BUG BAN PLUS Personal Insect Repellent
EPA Registration No. 44446-48**

Dear Mr. Whitney:

The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act, as amended, has completed reviewing all of the information submitted with your application to support the reregistration of BUG BAN PLUS Personal Insect Repellent (EPA Reg. No. 44446-48) in connection with the **MGK[®] Repellent 326 RED**, and have concluded that your submission is acceptable with the following label revision provision(s):

General Comment(s):

1. Delete all text throughout the label marked with "strikethrough."
2. Delete the statement (top of page 3 of 3): "[CONTAINS (CAS#): Isopropyl Alcohol (67-63-0), Propane/n-Butane (68476-86-8), Diethyltoluamide (134-62-3), N-octyl bicycloheptene dicarboximide (113-48-4), Acetone (67-64-1).]" since this information is incorrect and/or incomplete. As explained in Chapter 5, Section X.B. of the Agency's Label Review Manual: "If a registrant wants to list a particular active ingredient (in the ingredient statement), the registrant must list **all** inert ingredients directly below the ingredient statement."

Precautionary Statements, Hazards to Humans and Domestic Animals section comment(s):

3. Revise this section heading to read: "**HAZARDS TO HUMANS**" since this product is not registered for application to domestic animals.

First Aid Statement comment(s):

4. Replace the statement starting with "For additional information..." with: "**For additional information on this pesticide product (including health concerns, medical emergencies or pesticide incidents), you may call 1-800-255-3924.**"¹

Directions for Use section comment(s):

5. To facilitate inclusion of language from the MGK[®] Repellent 326 RED, insert the following text immediately preceding the 6th sentence as follows: "Do not apply more than 3 times per day to children ages twelve (12) and under."
6. In the 12th sentence, replace the word "rate" with the word "rare."

¹ Please note that the "1-800-255-3924" number listed must be available twenty-four (24) hours per day, seven (7) days per week for answering and responding to any medical emergencies or health concerns.

Directions for Use section comment(s), continued:

7. Revise the subsection title "FOR CLOTHING:" read "FOR OUTER SURFACES OF CLOTHING:"

The Agency determined in the DEET RED document that all aerosol and pump spray formulations must be packaged in containers utilizing a concave trigger to help aim product or other comparable mechanism that will ensure that the product will not be inadvertently sprayed in the eyes. In addition, current labels on DEET repellent products tend to dissolve from contact with the repellent (usually liquids). All reregistered DEET product labels must use materials that remain permanent and readable for the reasonable life of the product.

The Agency is also in the process of developing and improving the current Efficacy Assessment Guidelines for repellent products. The Agency intends to defer the determination of any related efficacy data requirements supporting the claims that may appear on this label until these Efficacy Assessment Guidelines are complete. When the guidelines are finalized, the Agency expects to issue a Data Call-In to address the revised guidelines to all registrants with registrations for personal repellent products that have not previously submitted efficacy data sufficiently consistent with the revised guidelines.


Quest Chemical Corporation should also note that a notice of availability of EPA's RED for products containing MGK® Repellent 326 was published in the *Federal Register* on May 23, 2003 (Volume 68, Number 100, Pages 28216-28218). In addition, EPA's RED for products containing MGK® 264 was published in the *Federal Register* on July 26, 2006 (Volume 71, Number 143, Pages 42381-42383). As a result, additional data and/or labeling changes may be required for products containing MGK® Repellent 326 and MGK® 264.

Should you wish to add/retain a reference to the company's website on your label, please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR §156.10(a)(5) lists examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not be substantially differ from those claims approved through the registration process. Therefore, should the Agency find, or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA-approved registration, the website will be referred to EPA's Office of Enforcement and Compliance Assurance (OECA). As an alternative, you may refer consumers to the company's phone number or e-mail address.

NOTE: This product is not being reregistered under Section 4(g) of FIFRA at this time.

A copy of your label stamped "Accepted with Comments" is enclosed for your records. Please submit two (2) copies of the final printed labeling, incorporating the above changes, before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). When using on children, apply to your own hands and then put it on the child. Use just enough repellent to cover exposed skin and/or clothing. Do not use under clothing. Avoid over-application of this product. After returning indoors, wash treated skin with soap and water. Wash treated clothing before wearing it again. Use of this product may cause skin reactions in rate cases. If you suspect a reaction to this product, discontinue use, wash treated skin, and call your local poison control center. If you go to a doctor, take this product with you. Do not spray in enclosed areas. If used on the face, spray on hands first and then apply sparingly and avoid eyes. Do not spray directly onto face.

Remove protective cap, and spray from a distance of 8-12 inches from surface to be protected. Slightly moisten surface—saturation is not necessary. Use slow sweeping motion.

FOR EXPOSED SKIN AREAS, to repel flies, gnats and mosquitoes: Use as directed above.

FOR CLOTHING, to repel ticks, fleas and chiggers—Apply along all openings of clothing, such as around the neck band, the fly and cuffs of trousers, tops of socks, eyelets of shoes and areas of clothing which may contact the ground, weeds or other growth.

Avoid contact with plastics, such as eyeglass frames, and such fabric as acetate rayon. Exposure to temperatures above 130°F may cause bursting. May damage some plastics, varnished or painted surfaces. May be used on Nylon, Orlon, Wool, Cotton. **DO NOT USE** on Rayon, Spandex or Dynel.
