Harmful if swallowed or absorbed through skin. Contains petroleum distillate. Do not induce vomiting because of aspiration pneumonia hazard. Do not breathe vapors or spray mist. It reaches fleas hidden in carpets, rugs, drapes, upholstery, pet bedding, floor cracks. Protects your home from reinfestation, flea buildup, and your pets and family from bites.
