The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Permethrin and Tetramethrin Interim Decisions and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. ### **CAUTION**

This pesticide is extremely toxic to aquatic organisms, including fish and invertebrates. Do not apply directly to or near water. It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

#### **Use Restrictions**

- For spot, crack, and crevice application only. Spot treatments must not exceed two square feet in size (for example, 2 ft. by 1 ft. or 4 ft. by 0.5 ft.).
- Treat surfaces to ensure thorough coverage but avoid runoff.
- To treat insects harbored in voids and cracks-and-crevices, applications must be made in such a manner to limit dripping and avoid runoff onto untreated structural surfaces and plants.
- Do not apply more than 112 lbs. (1792 ounces or 89 bottles) of this product (0.56 lbs. ai PBO) per 1000 square feet.
- Not for broadcast use on indoor surfaces.
- Do not apply this product in a way that will contact adults, children, or pets either directly or through drift.
- Do not allow adults, children, or pets to enter the treated area until sprays have dried.
- Do not apply when food is present. Remove or cover dishes, utensils, food processing equipment, and food preparation surfaces, or wash them before use.
- Remove pets, birds and cover any water inhabited by fish (such as aquariums and ornamental fish ponds) before spray application. Turn off aquarium filtering systems before spraying and wait approximately 15 minutes after application before turning the filter back on. [Remove pets, birds, and cover fish aquariums before use.]
- Do not use in commercial food/feed handling establishments, restaurants or other sites where food/feed is commercially prepared or processed. Not for use in federally inspected meat and poultry plants.

All outdoor spray applications must be limited to spot or crack-and-crevice treatments only, except for the following permitted uses:

- Application to pervious surfaces such as soil, lawn, turn and other vegetation
- Perimeter band treatments of 7 feet wide or less from the base of a man-made structure to pervious surfaces (*e.g.* soil, mulch, or lawn)
- Applications to vertical surfaces (such as the side of a man-made structure) directly above impervious surfaces (e.g., driveways, sidewalks, etc.) up to 2 feet above ground level
- Applications to vertical surfaces directly above pervious surfaces, (such as soil, lawn, turf, mulch or other vegetation) only if the pervious surface does not drain into ditches, storm drains, gutters, or surface waters.

For best results, spray in early morning or late evening when insect activity is minimal. Stand a safe distance from nest and not directly underneath. [Remove protective cap.] Hold can upright and point spray opening toward nest with wind at your back. Spray until nest is thoroughly saturated to kill the entire nest population. Residual action will kill *Wasps* and *Hornets* returning to the nest. Wait at least 24 hours before removing the nest.

To kill *Wasps, Hornets, Yellow Jackets* and *Bees* under eaves, screens, window frames, doors, patios, cracks, holes or crevices wherever insects are noticed, spray for about 1 - 2 seconds or until surfaces are moist. To prevent entrance of insects into the house, spray around points where insects can enter house; outside plumbing, faucets, and cracks or crevices in foundation as well as along sills and ledges.

Do not spray vegetation directly to prevent damage to foliage. If spray accidentally contacts foliage, immediately wash with water. This product may discolor exterior surfaces of building, structures and painted surfaces and may cause staining (darkening) of asphalt surfaces and shingles. Test product in an inconspicuous area before applying.

#### STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Do not pour or dispose down-the-drain or sewer. Call your local solid waste agency for local disposal options.
