# **General Precautions & Use Restrictions**

- Apply only as specified on this label
- Do not contaminate food or feedstuffs.
- Do not use in aircraft cabins.
- Except when applying through an automatic timed dispenser, do not enter or allow others to enter until sprays have dispersed and the treated area has been thoroughly ventilated. Do not remain in treated area. Exit area immediately and remain outside the treated are until sprays have dispersed
- Except when applying through an automatic timed dispenser, do not apply this product in a way that will contact workers or other persons either directly or through drift. Only protected handlers may be in the area during application.
- Remove or cover exposed food and drinking water before application. Remove or cover dishes, utensils, food processing equipment and food preparation surfaces or wash them before use.
- For indoor food handling/processing facilities: Do not make space spray applications when facility is in operation. During space spray applications, cover or remove exposed food. During space spray applications, cover food processing surfaces or clean after treatment with a suitable detergent, rinse with potable water before use. Do not apply more than 1 time per day.

FLYING INSECTS: Flies, Sandflies, Mosquitoes, Gnats, Wasps, Small Flying Moths, Fruit Flies, Indian Meal Moths, Almond Moths, Foreign Grain Beetles.

Hold Container upright with nozzle away from you. Press valve down and spray as directed. To avoid possible staining of fabrics or surfaces, do not spray at close range.

Calculate the cubic feet of the area to be treated. Close all doors and windows. Pointing nozzle upward, direct the aerosol mist to all parts of the room, especially around windows and other light sources which attract these insects. Apply spray continuously at a rate of one second per 1000 cubic feet of space. Keep area closed for fifteen minutes after each treatment. Area treatments can be made when animals are in lounging barns or holding pens.

**Out of Doors:** For temporary protection from mosquitoes and flies, spray along ground and around bushes and trees. Do not spray ornamental shrubbery.

**MUD DAUBER AND WASP NESTS:** Spray aerosol directly on insects and their nests from approximately 2 feet distance. Applications should be made in late evening when insects are at rest. Spray liberally into hiding and breeding places contacting as many insects as possible.

CHOCOLATE MOTHS, CARPET BEETLES, DRUG STORE BEETLES IN EXPOSED ADULT LARVAE STAGES: Contact as many insects as possible when treating infested areas such as cracks, crevices, packaged store products, machinery, dark secluded areas. Spray 10 to 20 seconds per 100 square feet of floor space.

**FLEAS IN BUILDINGS:** Close windows and doors. Hold aerosol 36" above floor and direct fog toward floor and lower walls at a rate of 10 seconds per 100

square feet, making sure that all floor, sofa & chair surfaces are contacted. Remove and destroy pet's old bedding. Thoroughly treat area and allow to dry before replacing bedding. Also treat dogs and cats with a registered flea control product before allowing them to enter treated area.

ROACHES, SPIDER, WATERBUGS, ANTS, SILVERFISH, CRICKETS: Hold aerosol close to cracks and fog directly into them, contacting as many insects as possible. Apply freely to all possible hiding places behind baseboards, sinks, cabinets, coffee makers, meter boxes, manholes.

DIRECTIONS FOR HAND-HELD EQUIPMENT (Cylinder):

# How To Assemble #100 Applicator:

- 1. Remove valve protection cap from cylinder.
- 2. Chain cylinder to cart.
- 3. Affix the hose and applicator to the valve with slight pressure from a wrench.
- 4. Do not use without applicator.

# **How To Operate:**

- With applicator nozzle directed upward, open valve a full turn.
- 2. Keep the valve in the upright position at all times while in use.
- 3. Depress trigger on applicator handle to release spray.

OR

# How To Assemble #25 [#115] Applicator:

- 1. Remove valve protection cap from cylinder.
- 2. Insert cylinder into carrying bag.
- 3. Affix the hose and applicator to the valve with slight pressure from wrench, if necessary.
- 4. Do not use without applicator.

### **How To Operate:**

- 1. Sling strap of carrying bag over shoulder.
- 2. With applicator nozzle directed upward, open handwheel a full turn.
- 3. Keep the valve in the upright position at all times while in use.
- Depress trigger on applicator handle to release spray.
- 5. Valve must be tightly closed and the cap replaced for storage.

# FOR AUTOMATIC TIMED DISPENSER:

# Preparation of Factory and/or Warehouse Areas:

The preparation of factory or warehouse area is based primarily on the number of cubic feet of area to be treated. Several A-20 units can be mounted and wired in series. This enables two or more units to be activated simultaneously through the use of a single electrical timer.

Set timer to dispense product only when the facility is not in operation. Cover or remove food. Cover or remove all food handling surfaces, utensils, benches, shelving, etc. or thoroughly wash with an effective cleaning compound followed by a potable water rinse prior to use. Do not allow worker re-entry into treated areas until sprays have dried.

### Treatment of Factory and/or Warehouse areas:

The number of units is based on an application rate of 1.5 grams of A-20 per 1000 cubic feet.

How to Assemble and Operate SOLENOID VALVE (SA-5):

- Attach solenoid valve to cylinder with slight wrench pressure. Note: Valve should be attached in inverted position. Open cylinder valve 2 turns – check for leaks.
- 2. Invert cylinder and slide into bracket.
- 3. When utilizing triple nozzle automatic valve, set application timer to correspond with dosage recommendation on left/back panel.

The mechanical equipment used in the application of this insecticidal composition is covered by United States Patent Number 3,209,950 owned by Hub States Corporation.
