#### WARNING

Causes eye irritation. Do not get in eyes. Harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing dust and contact with skin or clothing. The granular formulation may cause skin sensitization reactions in certain individuals. Use eye protection and protective clothing such as coveralls, a long-sleeved shirt and impermeable gloves when handling this product. Wash thoroughly with soap and water after handling. Remove contaminated clothing, wash before reuse.

#### First Aid

If in eyes: Hold eyelids open and flush with a steady, gentle stream of water for 15 minutes. Call a physician.

If swallowed: Call a physician or Poison Control Center. Drink promptly a large quantity of milk, egg white, gelatin solution, or, if these are not available, large quantities of water. Avoid alcohol.

If on skin: Wash with plenty of soap and water. Get medical attention if irritation persists.

If inhaled: If breathing difficulty occurs, move individual to fresh air and get medical attention.

#### Environmental Hazards

Do not contaminate any body of water by direct application, cleaning of equipment or disposal of wastes.

#### STORAGE AND DISPOSAL

Storage: Store in original container only. In case of leak or spill, contain material and dispose of waste.

Pesticide Disposal: Do not contaminate water, food, or feed by storage or disposal. Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal: Completely empty bag into application equipment. Then dispose of empty bag in a sanitary landfill or by incineration, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.
