

Gentlemen:

Subject: Boron #101 EPA Registration No. 44757-3 Your Application Dated May 14, 1984

The amendment referred to above, submitted in connection with registration under FIFRA is acceptable, provided that you:

1. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:

a. A statement of Practical Treatment is required to appear on your label similar to the following:

STATEMENT OF PRACTICAL TREATMENT

Immediately contact Physician or Poison Control Center if swallowed. If eye contact occurs, flush eyes with plenty of water. Get medical attention if irritation persists.

- b. Add the following precautions to your Hazard to Humans and Domestic Animals section of the label: "Nay cause eye irritation. Avoid eye contact. Avoid contamination of food and feedstuffs."
- c. Your storage and disposal statements must be in compliance with PR Notice 83-3.

2. Submit five (5) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with PIFRA sec. 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

Using portable blowers, apply BORON # 101 into cracks and crevices behind stoves, cabinets, sinks, refrigerators, dishwashers, on water pipes and at any holes in the floor or baseboards. Remove all lower cabinet drawers kitchen, bathrooms and closets and apply BORON = 101 liberally into drawer wells.

The average 9 room house will require approximately 12 ounces of BORON=101 with an additional 12 oz. for the garage and basement for a thorough treatment. Repeat monthly or as needed.

FOR CONTROL OF COCKROACHES IN SEWERS

Apply this product at a rate not to exceed 12 oz. per 190 sq. ft.using portable blowers or air pressure tanks.
