

DIRECTIONS FOR

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

ABL-10 is used to control algae and fungi in recirculating commercial and industrial cooling systems. To its use, systems must be cleaned to remove sludge, slime, and other deposits. An initial slug addition of ABL-10 fluid ounces of ABL-10 per 1000 gallons of water to provide a concentration of 48 ABL-10 parts per million, is recommended. Repeat initial dosage of 1.53 ABL-10 per 1000 gallons of water is recommended. Subsequent slug additions of 1.53 ABL-10 per 1000 gallons of water should be employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions should be made in the sump. ABL-10 is used in air-washing systems that maintain effective misting. To its use, systems should be cleaned to remove sludge and other deposits. An initial slug dose of 24.7 ABL-10 per 1000 gallons of water should be employed every 2 to 5 days, or as needed. Repeat initial dosage until control is achieved. Subsequent slug additions of 1.2 fluid ounces of ABL-10 per 1000 gallons of water should be employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions may be made in the collection trays of the airwash system.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not stack more than four drums high. Leaking or damaged drums should be disposed of in a sanitary landfill. Spills should be absorbed in sawdust or sand and disposed of in a sanitary landfill when not in use.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product should be disposed of in a approved waste disposal facility.

CONTAINER DISPOSAL:

- 1. PLASTIC (Triple rinse for equivalent). Then offer for recycling or incineration, or, if allowed by state and local authorities, in a sanitary landfill, by incineration, or, if allowed by state and local authorities, in a sanitary landfill.
