**STORAGE & DISPOSAL**

**STORAGE:** Store in a cool area away from heat or open flame.

**DISPOSAL:** Do not reuse empty container. Wrap container and put in trash collection.

**FOR USE ON ORNAMENTAL PLANTS, INDOORS:** Pepperonia, Spirea, Philodendron, African Violet, Euonymus, Scaevola, Ferns, Crabapple Rose, Wisteria.

When sprayed directly on insects, this product kills sucking insects: Aphids, Spider Mites, Leaf Hoppers, Whiteflies and Mealybugs. Kills chewing insects: Japanese Beetles and Southern Army Worms.

**SHAKE WELL:** Spray both upper and lower surface of leaves from a distance of 12-14 inches until visibly wet. Repeat as needed.

**FOR OUTDOOR PLANTS:** For best results, spray in the evening or on a cloudy day when air is still. Avoid using in hot, bright sunshine. Use slow sweeping motion, holding the dispenser approximately one foot from foliage. Spray both upper and lower leaf surfaces until visibly wet. Repeat as needed.
