DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

GENERAL DESCRIPTION

This product is only for use on the surfaces of hulls on boats and vessels. This coating controls barnacles, algae and other marine foulings. It can be used in both salt and fresh water. Wear protective clothing such as gloves, long-sleeved cotton shirt, long pants and hat. Remove contaminated clothing and wash before reuse. While spraying paint or sanding boat surface, wear a mask of a respirator jointly approved by the Mining Enforcement and Safety Administration and the National Institute for Occupational Safety and Health.

STIR WELL BEFORE USING. We do not recommend thinning. However, if spray equipment used for application is such that thinning is necessary, NCI Reducer #2033 should be used, but only the minimum needed for good application properties.

NOTE: Excessive thinning will adversely affect dry film thickness due to lower solids and increased spreading rate.

SURFACE

New fiberglass or gel-coat — must be free of mold release compound and glaze must be broken with 80/120 grit sandpaper and sanding dust removed. S-80 Wax and Grease Remover is recommended for cleaning fiberglass before and after sanding for best results. Priming is not required.

Wooden Boats — Remove all residue before painting.

New wood — Reduce 25% with appropriate thinner and use it as its own primer. Follow with a minimum of one full coat without reduction.

Previously painted surfaces — Haul boat, pressure wash bottom clean. Remove all traces of loose and peeling paint. Sand all bare spots with 80 grit sandpaper. Scuff entire bottom with Scotch Brite pad, wipe clean.

Clean bare spots with S-80 Wax and Grease Remover. Apply 2 coats of 1277 barrier coat, with 3 hours dry time between coats. Allow to dry overnight.

Apply two coats of Tropikote to entire surface allowing 3 hours dry time between coats. A third coat may be applied to high wear areas.

Allow to dry 12 hours before launching.
