

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

BIOKARE BE-218 is used in recirculating commercial and industrial water cooling systems must be cleaned to remove algal growth, other deposits. An initial slug addition of 3.3 BIOKARE BE-218 per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 1.1 to 1.1 BIOKARE BE-218 per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water cooling systems.
