DIRECTIONS FOR USE

It is a violation of Federal law to use this pesticide in a manner inconsistent with its labeling.

BIOCIDE M

is used in recirculating commercial and industrial water systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 6.0

BIOCIDE M

per 1000 gallons is recommended. Repeat initial dosage until control is achieved.

Subsequent slug additions of 2.0

BIOCIDE M

per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water.

ACTIVE INGREDIENTS:

Disodium cyanodithioimidocarbonate 4.20 %

Potassium N-methyldithiocarbamate 5.80 %

INERT INGREDIENTS 90.00 %

This product contains 0.89 lb. of active ingredients per gallon and weighs 8.90 lb. per gallon.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. STORAGE: Do not expose to extreme temperatures. Do not store five drums high. Drums should be opened in well-ventilated areas. Damaged drums should be placed in overpack and disposed of. Do not be absorbed in sawdust or sand and disposed of in a container closed when not in use.
