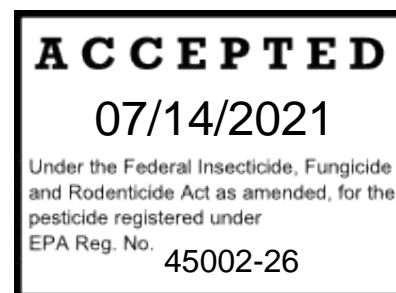

(1) **Terrestrial Food Crops:** Asparagus; atemoya; avocado; beets; biriba; bushberry subgroup 13-07B; cacao; caneberry subgroup 13-07A; canistel; canola; cherimoya; cole crops (broccoli, cabbage, cauliflower); cranberry; cucurbit vegetables crop group 9; custard apple; dill; eggplant; garbanzo bean; ginseng; globe artichoke; herbs (dried and fresh); ilama; leafy vegetables (except brassica) crop group 4; mango; okra; onion, bulb, subgroup 3-07A; onion, green, subgroup 3-07B; papaya; pepper; radish; sapodilla; sapote (black and mamey); small fruit vine climbing, except grape, subgroup 13-07E; snap bean; soursop; spinach; star apple; star fruit; stone fruit crop group 12; succulent shelled beans*; sugar apple; strawberry; turnip greens; walnut; wasabi (greenhouse).

*End-use product labels that allow use on succulent shelled beans must include the following sentence: Use of this product on succulent shelled beans is permitted only east of the Mississippi River.

(2) **Terrestrial Food and Feed Crops:** Almond, apple, barley, beans, buckwheat, citrus, corn, cotton, grape, hops, millet, peanut, pea, pineapple, potato, rice, root and tuber vegetables, rye, seed and pod vegetables, small grains, sorghum, soybean, sugar beet, sunflower, tomato, triticale, wheat.

(3) **Terrestrial Feed Crops:** Alfalfa, beans, clover, corn, cowpeas, grasses (forage, fodder, hay), lespedeza, lupine, millet, trefoil, vetch.

(4) Uses on golf courses, lawns, and landscape areas around residential, institutional, public, commercial and industrial buildings, parks, recreational areas and athletic fields; uses on ornamentals grown in container, bench, flat, plug, bed or in the field, in greenhouses, shadehouses, outdoor nurseries, retail nurseries, and other landscape areas.

Terrestrial Nonfood Crops: Fruit trees, golf course turf, nut crops/trees, ornamental and/or shade trees, ornamental herbaceous plants, ornamental lawns and turf, ornamental woody shrubs and vines, tobacco.

CONTAINER HANDLING:

Containers 5 Gallons or Less: Nonrefillable container. Do not reuse or refill this container. Triple rinse (or equivalent) promptly after emptying.

Triple rinse as follows: Empty the remaining contents into manufacturing equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into manufacturing equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities. Plastic containers are also disposable by incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.

Containers Larger than 5 Gallons: Nonrefillable container. Do not reuse or refill this container. Triple rinse or pressure rinse container (or equivalent) promptly after emptying.

Triple rinse as follows: Empty the remaining contents into manufacturing equipment or a mix tank. Fill the container 1/4 full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into manufacturing equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.

Pressure rinse as follows: Empty the remaining contents into manufacturing equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over manufacturing equipment or mix tank or collect rinsate for later use or disposal. Insert pressure-rinsing nozzle in the side of the container, and rinse at about 40 psi for at least 30 seconds. Drain for 10 seconds after the flow begins to drip. Then offer for recycling if available, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities. Plastic containers are also disposable by incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.
