DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. For control of fleas, ticks, cockroaches and other insect pests, thoroughly apply as a spray or spot treatment to infested areas: pet beds, kennel runs and resting quarters; nearby cracks and crevices; along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment of pet area. Repeat treatment in two weeks or as often as needed. **DO NOT TREAT PETS WITH THIS PRODUCT.** Use Zema Flea and Tick Spray for Dogs or Zema Flea and Tick Spray for Cats for pest control on pets.

STATEMENT OF PRACTICAL TREATMENT

If Inhaled: Remove victim to fresh air. Apply artificial respiration if necessary.

If Swallowed: Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person.

If On Skin: In case of contact, remove contaminated clothing and immediately wash skin with plenty of soap and water.

If In Eyes: Flush eyes with plenty of water.

Note To Physician: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine by injection is the preferable antidote. Oximes such as 2PAM may or may not be therapeutic, but it is recommended they not be used in place of atropine.

PHYSICAL OR CHEMICAL HAZARDS

ENVIRONMENTAL HAZARDS

Zema Indoor Premise Spray is toxic to fish, birds and other wildlife. Do not contaminate water by cleaning of equipment or disposal of wastes.

STORAGE: Store only in original container in locked storage area above 32 Degrees F. Do not use or store near heat or open flame.

DISPOSAL: Wrap original container in several layers of newspaper and discard in trash. Do not reuse container or sprayer. Rinse thoroughly before discarding in trash.
